Israt KHAN did, having entered into an undertaking given to a peace officer or an officer in charge pursuant to subsection 499 (2) or 503 (2.1) of the Criminal Code and being bound to comply with a condition thereof, namely NOT COMMUNICATE OR ASSOCIATE WITH & AWAY HOME, JOB, SCHOOL, WORHSIP OR ANY OTHER PLACE YOUNUS KHAN OR SONIA HOSSAIN ARE KNOWN TO BE, fail, without lawful excuse, to comply with that condition, contrary to Section 145, subsection (5.1) of the Criminal Code of Canada.

On February 25, 2019 the accused was arrested for domestic criminal harassment. As a result of the arrest the accused entered into an undertaking agreeing to conditions which included not to communicate with

the victim Younus KHAN.

On Friday March 1, 2019 the accused sent 32 text messages to the victim. The messages started at 0847 hrs and continued until 1743 hrs. The victim did not initiate or respond to any of the messages. The victim and his family are concerned for their safety as a result of the ongoing communication.

1 On Friday March 1, 2019 I PC SKINNER #3834 was employed by Durham Regional
2 Police Service and assigned to West Division. I was working in uniform
3 capacity and in a marked police vehicle.
4
5
6 At 22:14 hrs I received a call to attend [REDACTED]
7 in regards to Domestic Related Incident. Information received indicated that
8 the complainant, Younus KHAN was wanting to report that his ex girlfriend
9 Israt KHAN was breaching her conditions by sending him multiple text
10 messages throughout the day.
11
12
13 On route to the location, I conducted queries on the parties involved and
14 discovered that Younus is a victim of criminal harassment and the accused
15 was arrested recently on Monday February 25, 2019. The arrest incident
16 number is 19-41821. Information related to that incident indicated that the
17 accused, Israt KHAN and Younus were in a relationship for approximately 3
18 years. During the course of the relationship the police had been involved
19 several times with both parties being previously arrested for assault on
20 separate incidents. The accused had also previously been arrested for
21 criminal harassment in 2018 and is on a probation as a result of that
22 incident.

1

2

3 Further to the background, Israt was arrested on the 25th of February in
4 regards to on going harassment of Younus and his family. Israt is alleged to
5 have hacked Younus' email, Facebook and other social media accounts and send
6 inappropriate images and messages. Israt was also showing up at the victim
7 and his family's places of employment.

8

9

10 Israt was released on an undertaking which included conditions of not to
11 communicate with Younus KHAN.

12

13

14 She is also on a probation for a conviction due to the previous criminal
15 harassment case. The probation included a condition of keep the peace and be
16 of good behaviour.

17

18

19 I arrived on scene at 22:29 hrs and spoke to Younus. Younus was visibly
20 upset and was concerned for his safety. He was with a family member Sonia
21 HOSSAIN who is also listed as a victim of the harassment from the previous
22 arrest.

23

24

25 Younus advised that today he has received 32 text messages which included a
26 video chat request. The messages were not threatening in detail. The
27 messages started at 0847 hrs and continued until 1743 hrs.

28

29

1 Younus showed the messages to myself and I had him send screen capture
2 images to me via email. The messages have been attached to the report.

3

4

5 Younus has not responded to the messages and does not want to have any
6 contact with her anymore. He is legitimately concerned for his safety along
7 with the safety of his family.

8

9

10 He feels that Israt's behaviour is unpredictable and he feels that she will
11 escalate the harassment and possible physical violence since she has
12 recently been arrested. He feels he has to look over his shoulder every time
13 he leaves the house.

14

15

16 Younus does not know where Israt is staying currently but feels she may be
17 staying at the Warden Woods Shelter in Scarborough or the Womens Shelter in
18 Whitby.

19

20

21 I returned to the station to conduct checks and to prepare the charges of
22 Fail To Comply With Undertaking and Probation.

23

24

25 I had made a call to Israt's cellphone with negative results.

26

27
