1 On Saturday, February 23, 2019, I PC Elliott #3683 was in uniform on
2 general patrol in the City of Pickering in the Region of Durham.

5 At 2126 hrs, I received a radio call to atten [REDACTED] in regards to a
6 domestic related call for service.

7

8

9 Information received was that the complainant's friend is staying with her
10 while the friend is going through a separation. Further information provided
11 was that the friend's ex has hacked into his Facebook account and is sending
12 the complainant harassing and derogatory messages. The complainant's friend
13 is wanting to report this as a domestic incident.

14

15

16 At 2129 hrs, I arrived on scene. I conducted a door knock and was invited
17 inside by a female who identified herself as the complainant and homeowner,
18 Sonia HOSSAIN (198 [REDACTED] HOSSAIN then introduced me to her friend who
19 identified himself verbally as Younus KHAN (1988 [REDACTED]

20

21

22 I asked KHAN about what had happened. KHAN advised the following. KHAN

1 advised that he has been in an on/off relationship for the past 3 years with
2 a female named Israt Jahan KHAN (1979/08/15). KHAN advised that he met Israt
3 online and that she was from Newfoundland. KHAN advised that at one point in
4 the relationship he was charged with assault. KHAN advised that later in the
5 relationship, Israt was charged with assault with a weapon against him. KHAN
6 advised that once all of the charges and conditions were over with, he and
7 Israt moved back in together to continue their relationship. KHAN advised
8 that he quickly realized that he made a mistake because Israt would
9 constantly get him into trouble. KHAN advised that he recently decided to
10 separate from Israt and start a new life. KHAN advised that he sought help
11 from his friend Sonia who allowed him to stay at her house while he gets
12 back on his feet.

13
14 Before getting into what happened today, KHAN explained to me that during
15 the rocky relationship, for a while he and Israt shared one phone. KHAN
16 continued and advised that because he used Israt's phone so often, his G
17 -mail account, Yahoo account and Facebook account were all logged in on
18 Israt's mobile device. KHAN advised that he now has his own cellphone which
19 is electronically paired up with Israt's cellphone which gives both devices
20 direct access to KHAN's email and Facebook accounts. KHAN advised that today
21 Sonia (friend) confronted KHAN about some rude Facebook messages he had sent
22 her over Facebook messenger. KHAN advised that he was confused since he
23 never sent rude messages to anyone. Upon investigation, KHAN realized that
24 someone had hacked into his Facebook account and sent Sonia the rude
25 messages. KHAN advised he immediately suspected Israt as the person hacking
26 his account since she has direct access to his Facebook account on her
27 cellphone. Furthermore, KHAN advised that the messages sent to Sonia were
28 accusing her of having sex with KHAN which further added to his suspicion
29 that it must be Israt. KHAN advised that he then started receiving phone

1 calls from friends and family accusing him of sending dirty and
2 inappropriate messages to their facebook accounts. KHAN advised that he had
3 to explain to everyone that Israt had hacked his account and was behind the
4 messages.

5

6

7 Sonia HOSSAIN showed me the messages in her Facebook account that were sent
8 from Younus KHAN's account (suspected as sent by Israt KHAN). The messages
9 read "Now you are keeping Younus at your basement, you are great... ha,"
10 "just wondering you are not fucking him when Reza is away... he knows great
11 moves."

12

13

14 I asked that HOSSAIN and KHAN send me (in an email) the screen shots of the
15 messages which were allegedly sent by Israt using Yousun's profile.

16

17

18 I then asked KHAN about what he was hoping police could do for him. KHAN
19 advised that he hoped police could get Israt to stop hacking his accounts
20 and cease from contacting or trying to communicate with him. I then asked
21 KHAN if there were any other incidents involving Israt lately. KHAN then
22 advised that approximately one week ago, his boss "Kurt" told him that he
23 saw Israt hanging out front of KHAN's workplace ("Office Stock", 80 Rolark
24 Dr Scarborough). When asked about how this made him feel, KHAN advised that
25 he was afraid of Israt. See Younus KHAN statement in text pages.

26

27

28 I then attempted to phone Israt KHAN's number as provided by Younus. The

1 phone went straight to an automated message where I was unable to leave a
2 message due to there being no voice mail set up. Around the 4th time I
3 called, someone picked up and remained silent on the other end. I could hear
4 the breath of the person on the other line. I believed it was most likely
5 Israt KHAN being difficult as Younus warned me she would be.

6

7

8 I then spoke with DVI D/C John Rowan about the incident. D/C Rowan agreed
9 that a Criminal Harassment charge should be considered based on the
10 following reasons:

11 - Israt KHAN allegedly hacking Younus KHAN's Facebook account and sending
12 harassing messages to his friend's and family

13 - Israt allegedly showing up unannounced at Younus KHAN's workplace

14

15

16 At this point there is no immediate threat to Younus KHAN's safety since
17 Younus lives in [REDACTED] and Israt KHAN lives in Woodbridge. Also, KHAN advised
18 that he did not believe Israt would show up at Sonia's house where he is
19 staying.

20

21

22 I then went over safety planning with KHAN. I advised KHAN to cease from all
23 contact with Israt (block numbers/accounts). I advised KHAN to phone his
24 email providers and the Facebook help line to shut down his accounts since
25 they are now compromised. I advised KHAN to phone 911 if he feels Israt is
26 following him or if he feels unsafe for any reason. KHAN advised he
27 understood.

28

29

1 To follow up with KHAN's boss "Kurt" with a statement.
